

**TERMS APPLICABLE TO U.S. GOVERNMENT PRIME CONTRACT OR SUBCONTRACT**

When the goods or services covered by this Purchase Order are for use by DEW in connection with a U.S. Government prime contract or subcontract, acceptance of this Purchase Order constitutes an acceptance of the following additional terms and conditions which are incorporated herein by reference.

Supplier will comply with (and where applicable will require its subcontractors and suppliers to comply with) all applicable Federal Acquisition Regulations (FAR), Defense Federal Acquisitions Regulations (DFARS) and any other agency specific regulations clauses, including but not limited to the following:

41 CFR 60- 1.4(a), 60-300.5(a) and 60-741.5(a)	These regulations (i) prohibit discrimination against qualified individuals based on their status as protected veterans or individuals with disabilities, (ii) prohibit discrimination against all individuals based on their race, color, religion, sex, sexual orientation, gender identity, national origin, age, disability, pregnancy, genetic information, veteran status or any other category protected by law, and (iii) require that covered prime contractors and subcontractors take affirmative action to employ and advance in employment individuals without regard to race, color, religion, sex, sexual orientation, gender identity, national origin, age, disability, pregnancy, genetic information, veteran status or any other category protected by law.
15 CFR 700; FAR 52.211-15	If this Purchase Order is a Defense Priorities & Allocations System rated order under a U.S. Government contract, Supplier shall adhere to the requirements set forth in 15 CFR 700.
Employment & Social Responsibility	All mandatory and applicable FAR, DFARS, and other agency clauses related to employment and social responsibility, including without limitation, FAR 52.203-12 through 19; FAR 52.222-21; FAR 52.222-37; FAR 52.222-40; FAR 52.222-50; FAR 52.222-54-56; and DFARS 252.203-7001, 7002, and 7004.
Cybersecurity	All mandatory and applicable FAR, DFARS, and other agency clauses related to cybersecurity and information protection, including without limitation, FAR 52.204-21, FAR 52.204-23, FAR 52.204-25, DFARS 252.239-7010, DFARS 252.204-7008, DFARS 252.204-7009, DFARS 252.204-7012, and DFARS 252.204-7018.
FAR 52.219-8; FAR 52.219-9; DFARS 252.219-7003	Promotion and engagement of small businesses in subcontracting opportunities.
FAR 52.245-1	For any U.S. Government property furnished or made available to Supplier by DEW in connection with this Purchase Order, Supplier shall abide by the government property management requirements set forth in FAR 52.245-1 with respect to such U.S. Government property.
